


# The engine maintenance business model




# Reporting Example – MTU HAN Performance Chart – 2020

Nevertheless high performance in all direct and indirect processes are generating a positive impact to cost productiveness!




1. Cost of Goods Sold (Umsatzkosten)



# Profit and Loss vers. positive and negative Cash Flow






## MTU Maintenance Hannover Act. 2020 in M€
